Handicapped Parking Spot on Yale Avenue

Solicitor Kilgore stated that the request for a handicapped parking spot on Yale Avenue, which was previously denied was based on erroneous information he had provided. A spot can be assigned, however the resident needs to be a full-time resident. William Kleinfelter stated that it was denied in April. Michael Bell made a motion to deny a handicapped spot on Yale Avenue. Robert Eynon seconded the motion, and all were in favor. Allan Feldman asked why it should be denied. William Kleinfelter stated that there is already limited parking space available for residents on Yale Avenue. In addition, there is an area located at Yale and State Street that is designated as no parking to allow for the emergency vehicles to get through. Deborah Simpson asked if the resident's status changes, can the request be revisited. Solicitor Kilgore responded, if they become a full-time resident, then yes it can be revisited. Deborah Simpson stated that she received an email from James Cassel regarding the handicapped spot and wanted to know if she should reply. William Kleinfelter stated that he had already replied to him.
